Work includes installation of new towers, structural modifications of and existing tower, installation of a prefabricated precast equipment shelter, backup generator system, ice bridges, chain link fenced compounds, site grounding systems, and other general site improvements. Tower steel for new towers, prefabricated precast equipment shelter, and generator system equipment have been previously procured for the project. However, installation of this equipment is required under this contract. Antennas, coax, waveguides, and radio equipment within the shelters will be provided and installed by Others.
